



Rotary District 5930 2019-2020

Rooted in Service Recognition Award



Qualification Requirements:

1. Club is in good standing with IRS
2. Club officers for the upcoming Rotary year (2019-2020), are reported to Club and District websites & My Rotary (data@rotary.org) no later than the end of June 2019.
3. Club officers for the upcoming Rotary year (2020-2021), are reported to Club and District websites & My Rotary (data@rotary.org) no later than the end of February 1, 2020.

Successfully complete any 6 of the 9 requirements described below:

1. Implement and document a membership recruitment and retention program. Program must include at least one membership recruitment event hosted by your club or in partnership with other clubs.
2. Participate as a sponsor, associate sponsor or contributor in a Rotary project providing service in one of the six Rotary Foundation "Areas of Focus" in another country (minimum financial participation should be equivalent to \$5 per club member).
3. Participate in at least **3** of the following District 5930 **Youth Services Programs** by sponsoring or co-sponsoring a:
 - a. Four Way Test Speech contest participant
 - b. RYLA participant
 - c. Early Act First Knight / Early Act
 - d. Rotaract Club
 - e. Interact Club
 - f. Youth Exchange participant
 - g. Adoption Awareness Picnic
 - h. Global Grant Scholar
 - i. District Grant Costa Rica or Veteran's Scholar
4. **Club President-Elect** attended **Lone Star PETS 2019** or a **PETS Alliance Multi-District PETS**.
5. At least **5% (rounded up to the next whole number)***, of club members attend 2019 District Assembly to train Club leadership and introduce interested Rotarians to the RI Strategic Plan including Becoming and maintaining a Vibrant club, Rotary leadership development, club administration, importance of our Rotary's Public Image and the Rotary Brand, Supporting Our Rotary Foundation and how it will support your Club service projects to be held on Saturday, May 18 at Texas A&M Kingsville.
6. At least **5% (rounded up to the next whole number)* of club members** attend the Rotary District 4:1 Exciting Rotary Leadership Institute training, Enhancing Rotary's Public Image in your community, Membership matters so take it to the next level, and Your Rotary Foundation in Action to be held in September of 2019.
7. At least **5% (rounded up to the next whole number)*, of club members** attend your 2020 District Conference for Rotarians, family, and Youth on May 1-3, 2020 at the Omni Hotel in Corpus Christi, Texas.

8. Data Entry. Complete 2 of the data entry requirements:
 - a. New members entered correctly and in a timely manner
 - b. Member demographic info 50% correct
 - c. Record member engagement information
9. Participate in a Polio Day event or a Rotary Peace event

Rooted In Service Clubs will receive a certificate and will receive special recognition at the District Conference in May of 2020 as well as other recognition on the District Website and Facebook page.

*The 5% number is capped at 6 club members. I.e. We would of course encourage more but if your club has 120 members or more the maximum number of members required for attendance to qualify for the Rooted in Service Award is 6.

Note: Deadline for completion of the Rooted in Service Club application, found on the District website and app, is May 1, 2020.
